GRANT COUNTY COUNCIL REGULAR SESSION August 16, 2017

The Grant Council met in regular session on Wednesday August 16, 2017 at 6:00 p.m. in the Council Chambers.

1. Call to order

President McWhirt called the meeting to order at 6:00 p.m.

2. Prayer

Councilman Conner led prayer.

3. Pledge of Allegiance

Councilman Leming led the pledge of allegiance.

4. Roll Call

In attendance were Council members Jim McWhirt, Frank Hix, Mark Leming, Mike Roorbach, Mike Conner, Shane Middlesworth and Mike Scott. Also present were Council Attorney Phil Stephenson, Chief Deputy Auditor Angela Jarvis, and Financials Deputy Stacey Stevens.

President Jim McWhirt expressed he needs to add 2 items to the agenda, he received after the agenda was prepared. Under new business item F will be the Van Buren Public Library to consider a board appointment. Under item G the County Prosecutor Jim Luttrull to consider replacement of some vacancies. After the reviews I am going to move up the old business item and get it take care of first.

5. Approval of Minutes

Councilman Scott moved to approve the minutes from the regular session for July 19, 2017. Second by Councilman Conner; motion carried 6-0. Councilman Middlesworth abstained as he was not present at the July 19, 2017 meeting.

6. Auditor's Report

Auditor Bainbridge is not present; Chief Deputy Auditor Angela Jarvis presented the Health Insurance report and the General Fund Balance report. Chief Deputy Jarvis stated Auditor Bainbridge expressed if there were any questions, Council may contact him with any questions they may have concerning either report.

New Business

A. <u>Review of Estimated Property Tax Levy Limits and Circuit Breaker Losses-</u> Grant Counties 2018 maximum levy gets calculated with 4 funds we are involved with: General Fund, Health Fund, Reassessment Fund, and Cum Bridge Fund, the maximum levy for 2018 is 13,867,918. The Assessed Value Growth Quotient for this year is 4.0%, the Department of Local Government Finance projects that levies in 2018 will be higher than they were in 2017.

President McWhirt expressed we are going to now take care of the Old Business item from last month's meeting. Judge Dana Kenworthy is here from Sup. Court II. Judge Kenworthy is asking for a correction in some of her salaries and for a transfer to cover those salaries. Councilman Conner made a motion to approve the salary adjustment along with the change in the salary amendment as requested. Second by Councilman Scott: motion carried 4-2.

Councilman Conner made a motion to approve the transfers as requested. Second by Councilman Scott; motion carried 7-0.

B. County Sheriff-

Sheriff Reggie Nevels is asking for a transfer of funds in the amount of \$51,444.59 from Level III to Sheriff Work Crew Salaries. Councilman Roorbach made a motion to approve the transfer as requested. Second by Councilman Middlesworth; motion carried 7-0.

Sheriff Nevels is also asking to fill two (2) vacancies. One is for a Dispatcher and one for Merit Deputy. Sheriff Nevels is asking to fill these vacancies as soon as possible. Councilman Roorbach made a motion to approve the filling of the two (2) vacancies as requested. Second by Councilman Conner; motion carried 7-0.

C. County Health Department-

Health Officer John Kennedy is asking to fill a vacancy of the Health Department Environmental Health Specialist. Dr. Kennedy is requesting to move an employee whom is being paid from grant money into this funded position. The salary would be 31,828.00. The second request is to fill the grant position that would then be vacant. Dr. Kennedy would like to raise this salary from 27,709.00 to 30,000.00. Councilman Roorbach made a motion to approve the replacement of the vacancies and not to increase the grant funded position, leaving it at 27,709.00. Second by Councilman Conner; motion carried 7-0.

D. County Recorder-

Recorder Pam Harris is requesting permission to continue a "Back Indexing" project. County attorney Kyle Persinger has looked at the addendum and says it is in order. Recorder Harris expressed the Recorder's office does have the funds in the "CISP" fund to cover the expense of this project. Councilman Conner made a motion for approval as requested. Second by Councilman Roorbach; motion carried 7-0.

E. County Commissioners-

Commissioner Mike Burton is requesting approval to hire a replacement for the Grant County Veteran's Service Officer. Commissioner Burton expressed they would like to have a replacement hired by September 18, 2017. Councilman Conner made a motion to approve the request to hire a replacement as requested. Second by Councilman Leming; motion carried 7-0.

Commissioner Burton is also requesting the Administrative Assistant be paid 27.20 per day, as she has stepped up to take on the duties of the Veteran's Service Officer. Commissioner Burton is asking this be retroactive to July 20, 2017. Commissioner Burton is also requesting 2,000 be transferred from Salaries to Part Time retroactive to July 20, 2017. This transfer is to pay a volunteer 9.00 per hour for up to 28 hours per week, until the new Veterans Affairs Officer is hired. Councilman Conner made a motion to approve paying the Administrative Assistant 13.60 per day and to amend the salary ordinance retroactive to July 20, 2017. Second by Councilman Leming; motion carried 7-0. Councilman Roorbach made a motion to approve the pay for the volunteer at 9.00 per hour for up to 28 hours a week during the vacancy period, with this being retroactive to July 20, 2017. Second by Councilman Middlesworth; motion carried 7-0.

Commissioner Burton expressed the Commissioners have been working with Ameresco to make some upgrades in the county, including the Sheriff's Department, the courthouse, the complex, and the D-Home. Ameresco was here in May and July with updates and are here for the final time to give Council a final estimated cost. Commissioner Burton stated he would let a representative from Ameresco begin the presentation.

Jeff Metcalf with Ameresco presented a print-out of the breakdown of the estimated cost of the project. The total cost is roughly 7.7 million dollars. Our committee suggested to the Commissioners to approve this scope of work, the Commissioners voted and approved the work. Today we are here for Council to begin putting in place the efforts to fund this work. Discussion ensued as to how the cost can be split up by project or put together as one project and cost. Councilman Conner made a motion to approve to queue the project and set the time table as one project with bonding as being the funding solution. Second by Councilman Leming; motion carried 7-0.

F. Van Buren Public Library-

Shiloh McMullen Director of the Van Buren Public Library is asking to appoint Henrietta Story as a board member of the Van Buren Public Library. This is a 4 year term, beginning August 1,

2017 and ending July 31, 2021. Councilman Conner made a motion to approve the appointment as requested. Second by Councilman Scott; motion carried 7-0.

G. Grant County Prosecutor-

Grant County Prosecutor Jim Luttrull is asking to fill 2 vacancies, a Child Support Enforcement (IV-D) deputy prosecutor and a Deputy prosecutor. Prosecutor Luttrull would like to fill these vacancies as soon as possible. Councilman Middlesworth made a motion to approve the filling of the vacancies as requested with any domino effect that may come with it, and to amend the salary ordinance. Second by Councilman Leming; motion carried 7-0.

President McWhirt stated the budget hearings are scheduled for August 23rd, 24th, 30th, and 31st. The next council meeting will be Wednesday September 20, 2017 at 6:00 p.m.

President McWhirt stated there will be a special called meeting on September 13, 2017 at 6:00 pm, to conduct the first public hearing on preliminary determination and to introduce bond ordinance and introduce additional appropriation resolution.
