## GRANT COUNTY COUNCIL REGULAR SESSION November 20, 2019

The Grant County Council met in regular session on Wednesday November 20, 2019 at 6:00 p.m. in the Council Chambers.

#### 1. Call to order

President Middlesworth called the meeting to order at 6:01 p.m.

## 2. Prayer

Robert Jackson let the prayer.

## 3. Pledge of Allegiance

Councilman Hix led the pledge of allegiance.

## 4. Roll Call

In attendance were Council members Shane Middlesworth, Frank Hix, Mark Leming, Mike Roorbach, Mike Conner and Jonathan Perez. Also present were Council Attorney Phil Stephenson, Auditor Jim McWhirt, Chief Deputy Auditor Angela Jarvis, and Financials Deputy Nissha McCormick. Councilman Mike Scott was absent.

## 5. Approval of Minutes

Councilman Perez moved to approve minutes from the Executive Session on October 2, 2019 and the Special Session on October 2, 2019. Second by Councilman Leming; motion carried 5-1 (abstention).

Councilman Perez moved to approve the minutes from the Regular Session on October 16, 2019. Second by Councilman Leming; motion carried 6-0.

<u>6. Auditor's Report-</u>Auditor Jim McWhirt reported from several different financial reports, expressing there is not much he has to say about any of the reports.

## **New Business:**

**A.** Gas City Development Commission—Mayor Larry Leach made a request to reappoint David Huffman for 2020 (yearly term). Councilman Conner made a motion to approve the request. Second by Councilman Leming; motion carried 6-0.

**B.** Superior Court II-Magistrate Brian McLane presented for Judge Dana Kenworthy. Magistrate McLane is asking for a transfer of \$7,400.00 from Appeals & Pauper Counsel to the Salary fund to cover a shortfall. Councilman Conner made a motion to approve as requested. Second by Councilman Perez; motion carried 6-0.

- **I.** County Clerk-Brenda Russell presented for Clerk Pam Harris and is asking for the following transfers: \$1,060.00 from Part-time to Traveling Board and \$295.00 from Meals to Rental of Equipment. Councilman Conner made a motion to approve the transfers as requested. Second by Councilman Perez; motion carried 6-0.
- <u>J. County Assessor</u>-Nancy Leming presented for Assessor Rhonda Wylie and is asking to transfer \$51.92 from Training to Travel and \$30,000.00 from Contractual Services to Equipment. Councilman Conner made a motion to approve the transfers as requested. Second by Councilman Perez; motion carried 6-0.

Nancy Leming is also asking to transfer \$14,850.86 from Part-time to Full-time due to doing away with the part-time position and making it a full-time position. Councilman Conner made a motion to approve the transfer as requested. Second by Councilman Perez; motion carried 6-0.

County Prosecutor-Jamie Moore presented for Prosecutor Rodney Faulk and is asking to transfer \$7,000.00 from Witness Fees Prosecutor salaries account, and \$260.00 from VOCA to VOCA salaries account. Councilman Conner made a motion to approve the transfers as requested. Second by Councilman Leming; motion carried 6-0.
- **N.** County Sheriff-Reggie Nevels is asking for an appropriation of \$50,000.00 for salaries. Councilman Conner made a motion to approve as requested. Second by Councilman Leming; motion carried 6-0.
- O. County Recorder-Kathy Foy is asking to amend the salary ordinance for 2020, increasing the part time rate in the Recorder Perpetuation Fund from \$8.382 per hour to \$11.50 per hour. Councilman Conner made a motion to approve as requested. There was no second, motion died. Councilman Roorbach made a motion to approve increasing the rate from \$8.82 per hour to \$11.03 per hour to match County General Recorder 2020 part-time rate. Second by Councilman Conner; motion carried 6-0.
- **P.** County Auditor-Jim McWhirt is asking for the following additional appropriations: \$40,000.00 in Spot Light on Violence, \$71,000.00 in the CEDIT Fund and \$60,400.00 in the Prosecutor's IV-D Incentive Fund. Councilman Conner made a motion to approve as requested. Second by Councilman Leming; motion carried 6-0.
- Q. Loan Proposals-Auditor Jim McWhirt provided Council with two proposals for financing the Central Dispatch Center renovations. Auditor McWhirt expressed he sent letters to request proposals to the following banks: First Farmers Bank & Trust, Star Financial Bank, Grant County State Bank, Mutual Bank and Old National Bank. Only two banks responded, First Farmers Bank & Trust and Mutual Bank. Auditor McWhirt expressed Mutual Bank has a better interest rate for a 5-year term at 2.99%. First Farmers rate is 3.40%. After further discussion, Councilman Roorbach made a motion to approve Ordinance #2019-2 for \$750,000.00 with Mutual Bank, the rate not to exceed 2.99%. Second by Councilman Conner; motion carried 6-1 (abstention).
