# GRANT COUNTY COUNCIL REGULAR SESSION December 15, 2021

The Grant County Council met in regular session on Wednesday December 15, 2021 at 6:00 p.m. in the Council Chambers.

### 1. Call to order

President Middlesworth called the meeting to order at 6:01 p.m.

#### 2. Prayer

Charlie Myers led prayer.

### 3. Pledge of Allegiance

Councilman Middlesworth led the pledge of allegiance.

# 4. Roll Call

In attendance physically were Council members Shane Middlesworth, Frank Hix, Mark Leming, Mike Roorbach, Mike Conner, Chuck Poling and Mike Scott. Also physically present were Council Attorney Phil Stephenson, Auditor Jim McWhirt, and Financials Deputy Stacey Stevens. Chief Deputy Auditor Angie Jarvis was absent.

#### 5. Approval of Minutes

Councilman Scott moved to approve the minutes from the regular session October 20, 2021. Second by Councilman Leming; motion carried 7-0.

#### 6. Auditor's Report

Auditor Jim McWhirt expressed he sent each member his notes on the Auditor's report and we are in good shape financially. Auditor McWhirt noted in January we would have a new insurance carrier, UHC (United Health Care). Our budget has been approved by the DLGF.
