

**GRANT COUNTY COUNCIL  
REGULAR SESSION  
August 10, 2022**

The Grant County Council met in regular session on Wednesday August 10, 2022, at 6:00 p.m. in the Council Chambers.

**1. Call to order**

President Middlesworth called the meeting to order at 6:01 p.m.

**B. County Sheriff Department-**Sheriff Reggie Nevels is asking to amend the salary ordinance for the following eliminate 1 kitchen supervisor position and 2 cook positions and to add a Civilian Lieutenant position. Councilman Leming made a motion to amend the salary ordinance and add the Civilian Lieutenant position as requested. Second by Councilman Hix; motion carried 5-0.

**C. Area Plan Commission-**Mark Leming stated they had 3 people apply for the open position. After careful consideration we liked Randy Atkins most as our recommendation. Mr. Atkins would finish Mr. Florence's term which runs to December 31<sup>st</sup>, 2025. Councilman Hix made a motion to appoint Randy Atkins to the Area Plan appointment. Second by Councilman Leming; motion carried 5-0.

**D. Superior Court II-** Juvenile Magistrate Brian McLane is requesting an additional appropriation in the amount of \$5,424.12 to pay out an employee that is leaving and asking to be able to hire a new employee as soon as possible. Councilman Conner made a motion to approve being able to fill the vacancy as soon as possible and get the advertisement for the additional appropriation for the September meeting. Second by Councilman Roorback; motion carried 5-0.
