# GRANT COUNTY COUNCIL REGULAR SESSION November 16, 2022

The Grant County Council met in regular session on Wednesday November 16, 2022, at 6:00 p.m. in the Council Chambers.

### 1. Call to order

President Middlesworth called the meeting to order at 6:01 p.m.
